First time vendors must complete an application and submit payment prior to the Market they intend to vend. Payment for each Market will be collected at the market (unless other arrangements made). A new application is not required for each weekly market. Changes to products being sold must be submitted to Market Manager in writing and approved prior to making changes. Payment may be made with cash or check. Failure to make payment in timely manner could result in forfeiture of space for that week's market. 10x10 space \$20 to EDCFA members, \$25 to non-members.

Returning sellers set up in their same space each week. Spaces are 10x10 for each seller, with room behind display for storage. Sellers must offload their vehicle, then promptly move vehicle to designated Vendor Parking area. The parking area may change weekly depending on other evens happening at the Fairgrounds. Sellers of certified produce may park their vehicle behind their booth for food storage.

The Market opens at 4pm, vendors may arrive beginning at 2:30pm, and must be ready to sell at 4pm. The Market closes at 7:30pm, vendors must be packed and their area cleaned by 9pm.'

I understand and agree to comply with all rules and guidelines included in the El Dorado County Fair Association Farmers Market Rules, which are dated July 2020.

I agree and understand the participation of my farm/business is scheduled on a seasonal basis and my participation is not automatic and is subject to approval each year. Selling privileges of my farm/business are renewed in 30-day increments provided no negative compliance occurs. My renewal will be based on many factors including but not limited to: consistent reserved attendance, cooperation with Market Manager and other sellers, quality of products, volume sold of similar products, adherence to the market rules and regulations and adherence to the State of California direct marketing regulations and where applicable the State of California Uniform Retail Food Laws.

I agree, as a certified producer or as a non-certifiable agricultural producer at the El Dorado County Fair Associations' certified farmers market, that I will indemnify and hold harmless the El Dorado County Fair Association, the County of El Dorado and State of California, their agents, directors and employees, from and against any and all liability, claims, demands, expenses, attorney's fees and costs including expert consultant/witness fees, fines, penalties, suits, proceedings, actions and cause of action of any and every kind and nature arising or growing out of or in any way connected with my use or occupancy as a certified producer/non-certifiable agricultural producer at the EDCFA certified farmers' market. I agree that my stall holder is responsible for my sales area plus 6' around in addition to the area in which my equipment is located (vehicle, umbrellas, stands, signs, etc).

I also agree, as certified/non certified producer that I will maintain vehicle liability insurance on any vehicle I bring to the El Dorado County Fairgrounds, as well as product liability and general liability and workers compensation insurance, in effect while I am participating in the El Dorado County Fair Association certified Farmers Market.
