The 2018 El Dorado County Fair is pleased to host the "*El Dorado County Fair Idol*" Contest. All contestants shall preform at the preliminary competition being held on the **Budweiser Stage on June 16th beginning at 4:30 pm**. Three finalists shall be chosen to preform at the final competition on Sunday, June 17 at 7:15 pm on the Wells Fargo Stage.

Requirements:

- Contestants must reside within El Dorado County.
- Contestants must pre-register by June 13th by calling the Fair Office.
- Only solo vocalists may enter. Duets, trios, bands are not eligible.
- Contestants may sing acapella or to professionally recorded tracks, which contestants will supply on a CD. Lead vocals on the track must be removed.
- Accompaniment by any form of live musical instrument is not allowed.
- Contestants must preform at the preliminary contest in order to be eligible for the final competition.
- Minors under the age of 18 as of the day of the preliminary contest (June 16) must have a signed Contestant and Name Release authorization form signed and on file with the Fair office prior to the preliminary.
