- Open to any amateur band or musician.
- Sign-up times are determined on a first come, first serve basis.
- Bands are encouraged to sign-up early because limited space is available.
- Bands must provide their own instruments.
- Sound and technician is provided by Fair.
- All bands have exactly **20 minutes** (including set-up and break down) to perform on stage.
- All bands must include set-up and tear down times within their 20 minute slot (i.e. you won't be playing for the full 20 minutes, please keep this in mind when preparing your set list.)
- All bands must arrive at least 30 min before performance time and needs to have all equipment set-up as much as possible before taking the stage (i.e. drums assembled, cords connected to instruments, etc.).
- Music must be family appropriate (no swearing, etc.).
- **This is NOT a competition.**
- All members under 18 years of age must each bring a waiver of liability form signed by their legal guardian in order to participate.
