Contest Rules

- All dogs must be registered and accompanied by one adult who is 18 years of age or older and one additional handler (9 years or older). No other people are allowed in the race area. One will be with their dog at the starting line and the other will wait at the finish line.
- All dogs must be up to date on all vaccinations including rabies
- All qualified dog owners must sign a waiver of claims to be returned with entry form. No dog may enter the race without this signed disclaimer
- Dogs may only be registered to race once
- No entry fee required
- Check-in begins at 3:00pm and contestant numbers will be handed out. Costume Parade, Race and/or qualifying heats will be held in the Henningsen Pavilion.
- If a large number of dogs are entered, the top two dogs in each heat will advance to the final race
- El Dorado County Fair is not responsible for any injury caused to the entrant's dog or to themselves during their time at the El Dorado County Fair
- Owners may bring one toy for the dog. No lasers are allowed.
- No food, either human or people, is allowed in the race area. Dog bones are acceptable
- All dogs must be on leash and will be asked to leave if disruptive or uncontrollable.
- Owners must pick up after their own dogs
- Once race begins, handlers may not touch their dogs or push them onto the track, nor can the handler pull their dog over the finish line
- Decisions of officials and fair management of the El Dorado County Fair are final
- El Dorado County Fair has the right to publish the name, location and a recent photo of the winner without remuneration

CONTEST RULES

One will be with their dog at the starting line and the other will wait at the finish line. All dogs must be up to date on all vaccinations including rabies
- All qualified dog owners must sign a waiver and entry form. No dog may enter the race without this signed disclaimer.
- If a large number of dogs are entered, the top two dogs in each heat will advance to the final race.
- El Dorado County Fair is not responsible for any injury caused to the entrant's dog or to themselves during their time at the El Dorado County Fair.
- Owners may bring one toy for the dog. No lasers are allowed.
- No food is allowed in the race area. Dog bones are acceptable.
- All dogs must be on leash and staff reserves the right to ask any owner and their dog to leave for any reason.
- Owners must pick up after their own dogs.
- Once race begins, handlers may not touch their dogs or push them onto the track, nor can the handler pull their dog over the finish line.
- Decisions of officials and fair management of the El Dorado County Fair are final.
- El Dorado County Fair has the right to publish the name, location and a photo of all participants without remuneration.

RELEASE AND WAIVER OF LIABILITY AGREEMENT
