Requirements:

- Contestants must reside within El Dorado County
- Contestants must pre-register (by June 14) by calling the Fair Office
- Only solo vocalists may enter. Duets, trios, bands are not eligible
- Contestants may sing acappella or to professionally recorded tracks, which contestant will supply on a CD. Lead vocals on the track must be removed.
- Accompaniment by any form of live musical instrument is not allowed
- Contestants must perform at the preliminary contest in order to be eligible for the final competition.
- Minors under the age of 18 as of the day of the preliminary contest (June 18) must have a signed Consent and Name Release authorization form signed and on file with Fair office prior to preliminary.

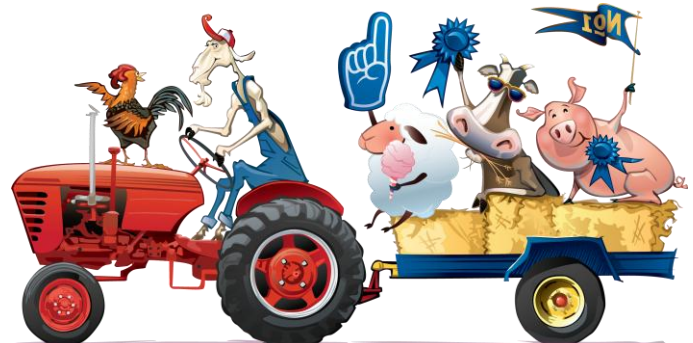
Description of Competition

The 2017 El Dorado County Fair is pleased to host the “El Dorado County Fair Idol” Contest. All contestants shall perform at a **preliminary competition** being held on the **Budweiser Stage on June 17 beginning at 4:30 p.m.**

Three finalists shall be chosen to perform at the final competition on Sunday, June 18 at 7:15 p.m. on the Wells Fargo Stage.

Judging Criteria:

- Vocal talent
- Stage presence
- Entertainment appeal
