#### IX. MANAGER'S REPORT

Gray met with Placerville City Manager Cleve Morris and Pierre Rivas, Director of Development Services regarding the electric sign at Denny's gate. They requested the Fair be careful with letter colors making sure they are not obnoxious. Also discussed was City Council has requested City Staff to create a new noise ordinance to reflect current times.

We were told Gold Week has been approved for outdoor music on Wednesday and Thursday until 10:00 pm. Hangtown Halloween has been approved until 9:00 pm on Wednesday and 8:00 pm on Sunday. Gray stated she is concerned about discrimination.

Gray passed out the 2016 VIP pins.

The next Board meeting is on May  $3^{rd}$  at 10:30 am in the Marshall Building. Lunch with the City of Placerville and County will follow.

We parked 900 cars for the World of Outlaws race and ran out of parking.

Senate Bill 2678 was introduced by Assemblyman Gray to provide a stable source of funding for state fairs and offer much needed help for specific fair-related purposes and projects. A portion of sales tax collected at Fairs is a funding stream from revenues that Fairs already generate. We wrote letters in support of Assemblyman Gray.

Livestock Quality Assurance and Ethics Training was held April 4th at 6:00 PM in the Marshall Building. This is something we are moving towards requiring every 5 years.
