**NO EARLIER THAN 7:00 AM, VEHICLES MUST BE PARKED IN DESIGNATED AREAS BY 8:30 AM**
- Payment in full guarantees a space in the Plaza, if rain we will move to Pav A & B (under cover)
- Must supply own tables(s) and chair(s) & hand sanitizer for general public.
- No refunds for no-shows.
- There are some power outlets for EVERYONE TO SHARE so that you can demonstrate an electronic item is in working condition to a potential buyer.  
**PLEASE NOTE:** these outlets are NOT available at every space and will need to be shared with fellow sellers.
- **Each seller is responsible for the removal of all unsold items and debris at the end of the event**
