- Entry Form & Payment** deadline May 7, 2025
All Livestock and Dogs
Signed by exhibitor, parent, leader/advisor.
- Adult Code of Conduct** deadline May 7, 2025
- Release of Liability** deadline May 7, 2025
- \$20 4-Day Admission Wristband** - required due with entry fees
available for exhibitor and family, only way to enter through livestock gate, must purchase when paying for entries
- \$70 4-Day Livestock Exhibitor Unlimited Carnival Rides Voucher** - optional limited time offer due with entry fees
available for exhibitor only, must purchase when paying for entries

FAQ's

1. **When do I get a Fair parking pass?**
 - Each family will receive one parking pass during the animal load in on June 9, 2025.
2. **Ownership Documents? What are those? (due no later than April 23, 2025 at 4:00 pm.)**
 - Ear Tag Form
 - Bill of Sale
 - Photo of Animal (entire animal, with ear tag readable. Swine must also include exhibitor)
 - Prop 12 Declaration Form (swine only)
3. **Entry Documents? What are those? (due no later than May 7 at 4:00 pm)**
 - Entry Form Completed (with all signatures)
 - Liability Release
 - Adult Code of Conduct
4. **There are so many forms to turn in! Can I submit them as I finish each one?**
 - No, we require all forms to be submitted together.
5. **Can I submit the Release of Liability and Code of Conduct form with ownership documents?**
 - Yes.
6. **Can I buy a 4-Day Livestock Exhibitor Carnival Voucher for a sibling?**
 - No, the \$70 carnival ride voucher is only for the livestock exhibitor. Siblings, friends, family, etc, need to purchase an \$85 Carnival Voucher through our pre-sale.
7. **\$70 is a lot of money to have ready to pay with the entry fees. Can I pay for the carnival voucher later?**
 - No, you need to purchase the Livestock Carnival Ride Voucher when you pay for your entries.
8. **My grandma wants to come on Thursday for senior day. Can she enter with us through the Livestock Gate?**
 - No. Only individuals wearing a livestock wristband will be allowed entry through the Livestock Gate during Fair - no exceptions.
9. **Can I submit all my forms and pay early when the Ownership Documents are due?**
 - Yes, but only if your project is completed and you have all the signatures needed. You do not have to wait until the deadline to submit.
