Kobervig: No report.

Warden: She was only one in VIP room (sad and lonely). Great time working the bar. Impressed at how well everything flowed.

Witherow: Great fair. Cap Bar and Tiki Bar comparison. Learning how to use the tap was an experience. Figured it out. Works best with one person pouring. Going between bars – too many options isn't that great. Bars should be more consistent with less choices.

Carter: Peewee Rodeo was a huge success. In Henningsen. Created 70 back numbers and had to write the last 30 or more by hand. Need to revamp to accommodate that many. Boot race needs to be changed as lots of kids show up in crocs and flip flops. Need to bring back Mutton Bustin'.

Added Peewee Showmanship to Livestock Show, it was very popular.

All liked kids' activities on the main lawn so they didn't just have the carnival as a go-to for fun. Heritage Hog after addons made \$70,500. Buyers paid about \$50,000 with addons coming to about \$70,000. Last live auction Heritage Hog made about \$30,000. Just finished several days at the State Fair.

Hunt: Fresno State Students doing the Master Showmanship were great. Amador Fair did not seem well attended this year, probably due to hHot weather.

Davis: Purchasing the Board of Directors' Hog. Frustrating that all 11 members did not participate. Need everyone to participate or it costs the members that are participating too much. Hunt's input – we could buy one and resell. Whitaker – it should be the board members responsibility to participate. It's about representing the Board of the Fair and supporting the kids. Carter – brought this to the table years ago and was equally frustrated that not all were participating. She was the only Board Member that participated in Heritage – maybe more members should participate with that.

Anyone can participate in the Heritage Hog addons. Wait until the hog is purchased by the buyers and then go see the clerk about adding any amount you can afford and want to pay to up the price.

Maybe we should have the Board should support the Heritage Hog. McGuire – maybe some can't afford to go in on buying a hog verses adding on to the Heritage Hog. Whitaker – more concerned with representing the Board of Directors of the Fair and not the Heritage Foundation. Can't do both if not everyone participates. Resale hog or donate to nonprofit. Board will discuss/resolve before next year's fair.

McGuire: Commented on the numbers of attendance at fair.. Someone spoke to him about an entertainer at Fair that they really liked. He told them to email the Fair office so they get invited back. Asked for clarification regarding RV park during the Fair for Vendors – they are paying \$45 and not \$55.

Whitaker: Gilmore Heating and Air are going to donate all installation costs of mini-split for Board Room remodel.

Feathers-Forni: Friday night Music at the Fair? How are we handling staffing? Need a few volunteers for Beer Tree Bar.
