- **D.** Signs on Highway 50 take people and half a day—Highway 50 signs through town are used by another organization. We can apply for a permit for 2025 but will need volunteers to put up and take down signs.
- **E.** We are both sides of the digital marquee at the Palladio and at Naturewood Home Furnishings on Hwy 50. Both will be up through Fair.

- **B.** Acknowledge 2023 Financial Audit: Audit complete and good. Witherow made a motion to acknowledge the STOP and the Audit. White seconded. Motion carried and approved.

6. Manager's Report

- A. Audit complete. No corrections or deviations from GAAP.
- **B.** Issues with Skate Park. Parks & Trails staff were frustrated with our patrols parking during their work hours (when events are happening that use the Tiers). They want permanent, designated spaces. On Sunday, June 2, the County Parks and Trails Department issued a permit to an individual to have an event at the skate park. We did not approve or were made aware of the event. Fighting, alcohol, pot. PPD responded, acknowledged the permit was valid, and didn't seem to have issues with the drinking or pot smoking (saw no minors consuming). Back in February, a promoter reached out about doing an event at the skate park... the skate park is county but tiers are ours to rent or use as we see fit.
- C. Wooden marquees at the Armory Gate have been taken down.
- **D.** Attended her first CCA Meeting enjoyed it. Learning about what CCA does for California fairs, and how they do it.
- E. Fair Guide is out.
- F. Livestock camping we got some backlash regarding cutting the camping in half.
- **G.** Got a quote for painting the water tower \$16,000.

- **H.** Have been reading a lot of Fair news. Several Fairs are instituting a chaperone rule. Parents will have to be at the fair with their kids. Cal Expo parents check in their kids and if they do something wrong, parents get fined if they are not present.
- **I.** Ticket sales To date, pre-sale admission tickets for 2023 was \$35,000 and pre-sale for 2024 is at \$42,000.

PPD will light up the crosswalk in front of Fair.

Specific radios will be issued to the bars that will call into the dispatch communication center if needed. Jason handed out his personal cell phone number for issues.

Kobervig: First year we are charging for grandstand events? Motorcycle and truck pulls. \$8 pre-sale and \$10 during Fair. VIP pens get 2 adults in and children 6 and under are free.
