- **B.** Fair Advertising. Digital signs at the Palladio in Folsom and next to Naturewood Furniture in Rancho Cordova (both on Hwy 50) flashing 2 weeks before Fair. Fair printed signs going up in May. Four Vendor spaces left. Hiring for Guest Services and Parking, etc. still going on. Dunkak spoke with Director Warden regarding the early meetings each day of the Fair. Dunkak proposed to discontinue meetings unless we need one. We will have Admission totals at the end of each night for reporting to the Board and recapping anything that happened. Director Bloxsom will give a daily report to Dunkak by the end of the night so that we will know and not rumors.

Supervisor Thomas will read one paragraph from the County Proclamation about what we have going on at the Fair this year. It will be on the Board of Supervisor's agenda next week.

Warden: The Board of Director's group photo is set for June 12 at 5:00 pm in front of Johnny's Gatehouse. Preview night is 6 – 9 pm. The Opening Ceremony will be short and sweet beginning at 11:50. The Explorers are coming in to do the anthem, and a presentation on the flag raising and lowering (they should be there at 11:30 to do the flag raising at 11:55). Livestock: Explorers raise flag during load in and take down on Sunday night. After opening, meet at the boardroom to take a ride in Vicini's fire truck. Roses will do the ribbon cutting.
