Welcome to the El Dorado County Fair & Event Center RV Park. Access to our park is off of Ray Lawyer Drive.

Directions from Highway 50 East or West bound:

Take the Placerville Drive/Forni Road Exit and head north over the freeway onto Placerville Drive. Continue on Placerville Drive to Ray Lawyer Drive (you will be passing one entrance to the fairgrounds).

Turn right on Ray Lawyer Drive, go 3/10 mile, and on your right you will see the gate to the RV park. Turn right into the gate access. The gate code is listed on the check out page (Please write it down). You may choose any site that does not have a "Reserved" sign.

The Gate code will gain also you access to the RV Restrooms. LAUNDRY FACILITY COMING SOON

Fair Office Hours: Monday-Friday 9am-4pm. Check calendar on website for holiday/furlough closures. **Maintenance Hours**: Monday-Friday 7am-4pm. Check Calendar on website for weekend hours/holiday and furlough closures.

Marshall Hospital is the closest hospital. Phone number is (530) 622-1441. Directions to hospital: Exit Park, turn left onto Ray Lawyer Drive, turn left onto Placerville Drive. Go over the freeway and enter Highway 50 east bound. Turn right at Bedford Avenue, Turn left onto Main Street, Turn right onto Cedar Ravine Rd, Turn left onto Marshall Way. Hospital is about 6 blocks down Marshall Way on the right side.

El Dorado County Fair RV Park Rules

- 1. Fees are \$ 45 per night per RV. Camping fees must be paid upon arrival. No refunds for early departures. Receipt for payment must be posted in a place visible to Fair staff.
- 2. RV Park guests must have current and valid insurance and registration for the RV and tow vehicle. These documents must be in the same name and RV Park guests must be prepared to present the documents to the RV Camp Host upon arrival.
- 3. RV and tow vehicle must be in good, clean, operable condition and not more than 10 years old. This determination is made at the sole discretion of the Fair staff. Any RV not meeting minimum standards will not be permitted to stay in the RV Park. Tow vehicles must remain available. "Drop offs" are specifically NOT allowed.
- 4. The Fairgrounds (El Dorado County Fair Association) is not responsible for fluctuations in electricity or water pressure and assumes no liability for any damages that changes may cause to your RV.
- 5. Speed limit on the Fairgrounds is 10 miles per hour.
- 6. Check in time is by dusk. Check out is by 1:00 p.m.
- 7. RV Park stay is limited to 14 consecutive days.
- 8. A secondary tent with a registered RV must be approved by the Fair staff. Secondary tents must be located within the same site as the RV.
- 9. Maximum occupancy of four people and one tow vehicle per site. Children must be under adult supervision at all times.
- 10. No vehicles may be parked in adjacent sites.
- 11. Dump station is available to campers (during staffed hours & dates) between 7:30 am and 3:00 pm for an additional fee. Usage must be arranged with Fair staff.
- 12. Quiet time is between 10:00 pm and 7:00 am. All noise activities, including loud voices and music, must cease by 10:00 p.m. Generators may only be used with approval of Fair staff. Generators must be off by 10:00 p.m. Any exceptions require the approval of the Fair staff. Please note that the Fairgrounds operates as a special events center and some events may result in noise after 10:00 p.m.
- 13. No pets allowed in restroom or laundry facility.
- 14. Pets must be on a leash (with the exception of dogs in fenced dog park area) or penned at all times when outside and must be picked up after. Dogs and other pets must not be a threat or a nuisance to other park users. Excessive barking is not allowed.
- 15. RV sites must be kept clean at all times. No clotheslines are allowed. All trash must be disposed in trash or recycle containers. (Located next to the RV Restroom).
- 16. Absolutely no black or gray water is to be dumped on the ground. No washing of RVs or vehicles.
- 17. Destruction or damage to trees and landscaping is prohibited.
- 18. Driving off-road vehicles on the Fairgrounds is prohibited. Roller blades, skates, scooters and skateboards are prohibited.
- 19. Weapons are prohibited. Fireworks are prohibited.
- 20. Found items must be turned in to Fair staff.
- 21. No wood-burning fires, open flames or charcoal barbecues allowed. Small propane barbecues only.
- 22. Any hazardous leak, or clean-up is the financial responsibility of the person responsible for the leak.
- 23. Any complaint involving local law enforcement agencies or Fairgrounds Management may result in immediate eviction.
- 24. El Dorado County Fair Association or its representative reserves the right to refuse service, to locate and relocate any vehicle in the vicinity of the RV Park according to space availability and space capacity, and may remove any vehicle from the RV Park for just cause. Refusal to move your vehicle or vacate the premises at the request of the RV Camp Host may result in your vehicle being towed at your expense.

The camper accepts camping privileges with the understanding that he/she does hereby release the

El Dorado County Fair Association, the County of El Dorado and the State of California, its officers and employees, of all liability for loss or damage to property and injury to his/her person arising out of his/her use of its camping facilities and agrees to defend and indemnify the El Dorado County Fair Association, the County of El Dorado and the State of California, its officers and employees, against all claims resulting from loss or damage to property or injury to the person of any member of the family or guest of the registered camper arising out of the use of the camping facilities. In the case of a defaulting occupant, the RV may be removed from the premises for the reasons specified in the California Civil Code Section 799.22. "Defaulting occupant" means an occupant who fails to pay for his or her occupancy in a park or who fails to comply with reasonable written rules and regulations of the park given to the occupant upon registration.
