## While Participating in the El Dorado County Fair

As an exhibitor in the El Dorado County Fair:

I will follow proper procedures and the chain of command if there is a conflict.

I understand that direct criticism or **interference with the judge**, fair volunteers and staff, other exhibitors, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, fair volunteers and staff, or other show officials shall be treated with courtesy, cooperation, and respect. I will not allow any person connected with my project to direct abusive or threatening conduct toward any fair volunteer, staff or show official. Protest rules can be found in the Entry Guide.
